PROJECT ABSTRACT

The Fanapi Foundation seeks funding to host a five-day residential educators training conference on July 29 – August 2, 2013 at Xavier High School on Weno, Chuuk State, Federated States of Micronesia for the public school teachers and principals from the Northwest Region of Chuuk.

The Northwest Educators Summer Training (NEST) 2013 aims to bring together all the public school teachers, principals, and some select community leaders from the outer island regions of Namonweito, Pafeng, and Pattiw which makes up the Northwest Unified Schools. While residing on campus for the duration of the weeklong training, the 65 participants will engage in a series of workshops, discussions, lectures, and classroom simulation exercises led by trained educators in the field of school administration, classroom management, and leadership development.

One goal of the conference is to provide an integrated hands-on leadership development program specific to the needs in the outer island public schools. Another is to build community and synergy among these educators so they may become effective leaders in the overall Chuuk State School System educational reform plans.

Funding in the amount of \$42,000 is needed to pay for training facilities, room & board, transportation, stipends for trainers, training materials, and other costs.

PROJECT NARRATIVE

Background

On July 2-7, 2012, educators and leaders from throughout the Northwest regions of Pattiw, Namonweito, and Pafeng converged at Northwest High School (formerly Weipat) on Onoun island to participate in the first Northwest Education Institute sponsored by the Chuuk State School System (CSSS). The goal was to explore ways to improve the quality of education for students of Northwest region and to build community support for the Chuuk Educational Reform Plan (CERP). What transpired at this historic meeting was beyond the usual expectations for the outer islanders; the participants elected to support and expand on the decentralization goal of the CERP by adopting to formulate key steps in building community-based support and ownership of "our own schools" rather than continuing to wait for the Department of Education to solve "our own problems for us."

The institute was reflective of the entire leadership of the Northwest region. The delegation comprised of all the public school teachers, principals, mayors, municipal council presidents, religious leaders, traditional chiefs (hamwools), political leaders, and representatives of concerned parents. In a show of incredible unity, the delegation unanimously formulated a resolution calling for the unification of all the public schools into the Northwest Unified Schools and sought funding support from the Department of Education. They also unanimously agreed to create a non-governmental organization called Fanapi Center to be located on the main island of Weno to support educational reform, facilitate community development, expand healthcare, and develop economic opportunities for the Northwest region.¹

The keynote speaker at this educational / leadership summit was Mr. Vidalino Raatior, a fellow outer islander, product of Chuuk State's public education, international educator who currently serves as the Director of the Pacific Islander Student Center at the University of Hawaii at Hilo. In a show of self-empowerment, the delegation asked him to serve as the lead consultant for the two initiatives. While accepting the responsibility, Mr. Raatior reminded the delegation of the

need to work within CSSS's efforts and other globally acceptable systems of nongovernmental operations.

The Northwest needed a US-based entity to access the vast global resources. On December 5, 2012, the Fanapi Foundation (www.fanapi.org/foundation) was officially charted as a program of the United Charitable Programs, a registered 501(c)3 non-profit public charity organization based near Washington, DC. Founded by Mr. Vidalino Raatior and led by an Advisory Board of experts, the Fanapi Foundation's mission is to raise funds and provide technical assistance to empower self-sufficiency among the people in the Northwest region.

The Fanapi Foundation is also the bridge with the Northwest people living overseas. Mr. Raatior's influence among the Northwest islanders in Hawaii, Guam, and the US mainland has served the organization's larger vision to engage the diaspora from these remote outer islands to be actively engaged in helping to address the neglected needs in education, healthcare, advocacy, and economic development.

Statement of Need

The students in the public schools in the outer islands of Chuuk are arguably the most underserved population in the entire Chuuk State. The remote location of the low-lying islands pose a major problem in access to the usual resources available in the Chuuk lagoon. These isolated islands depend solely on the state government specifically the CSSS to solve their educational issues. Over the years such dependency on the Weno-based department has negatively impacted their sense of ownership of the public schools. Whatever little progress found in these islands are attributed solely on the hard work and dedication of the teachers and principals even though they are far removed from any regular resources or training opportunities on Weno.

A major problem in the CSSS is the lack of qualified teachers and principals. Most of the qualified teachers in the entire State of Chuuk are concentrated in the lagoon schools closest to the main center of Weno. Currently, there is no program of incentivizing qualified teachers from the lagoon schools to teach in the remote islands. Consequently, the Northwest Unified Schools are left with a shortage of qualified teachers and principals.

Another major challenge of the Northwest Unified Schools is the lack of access to regular professional development programs to address the unique educational needs of these impoverished schools. The school principals are expected to develop and maintain effective training programs for their teachers within the CSSS year-round school calendar. Yet, most of the principals themselves have not been adequately trained as trainers. They are themselves products of this cycle of untrained administrators. Consequently, teachers from these remote schools have had no reliable professional development programs during the year; they depend on the summer months to travel hundreds of miles to the main island of Weno to access training programs developed by the CSSS and the College of Micronesia – Chuuk Campus.

There is a cycle of untrained educators in these outer islands. Most of them were educated in these poor educational environments and often have only a high school diploma from similarly poor public schools. Without ever experiencing a quality educational environment, or even seeing what one looks like, these teachers continue to perpetuate a cycle of educational poverty. Lacking a different approach, these schools breed student failure and hopelessness.

Educators at these public schools in the outer islands require a comprehensive experiential training program if they are to break the cycle of educational failure and become champions of educational reform. Efforts must include an experiential training in effective management of schools. The Northwest teachers and principals will benefit from an experience of what it might feel like if they went about their roles in a new orderly way. Just offering input for a couple of hours is not enough.

Northwest Educators Summer Training (NEST)

The Northwest Educators Summer Training (NEST) program is the only viable way to begin to break the cycle of subpar public education in the Northwest Unified Schools. NEST must be held on the central island of Weno, which has the resources and facilities for training purposes. It must be residential as most of the teachers have inadequate living situations on Weno. It must be held at Xavier High School, which is arguably the best college preparatory in the countries of Micronesia, Palau, and the Marshall Islands to enable them to experience what it takes to lead and maintain a successful school. It must bring together all the teachers and principals in the Northwest Unified Schools for a common experience. It must be must be led by well-trained professionals who understand the uniqueness of the cultural and educational reform issues in Chuuk State. NEST as with educational reform must be rooted within the historical context, reality, and support of key community leadership from throughout the Northwest region. And finally this NEST must be built upon the foundation of the leadership summit held a year ago on the Onoun Island.

NEST will be held at Xavier High School during the week of July 29 – August 2, 2013 and facilitated by the experienced team of educators led by Fr. Arthur Leger, SJ, Ph.D., Margaret Cholymay, Ed.D., and Vidalino Raatior, MA. The participants will reside at the dorms and participate in roundtable discussions, hands-on workshops, leadership development exercises, and engage each other in collaborative strategic planning. They will reside on the Xavier campus for the duration of the five-day conference to maximize collaboration and build community among the participants who normally have no access to each other as they are separated by the ocean. Additionally, the participants will have a daily experiential education in the Xavier High School culture of educating the whole person.

NEST Goals

The NEST proposes to accomplish the following goals:

- 1. Build capacity, advance collaborations, promote shared resources, and broaden awareness and understanding of teaching and leadership skills for the Northwest Unified Schools.
- Unify the collective experiences, expertise, and skills of the participants in order to develop a culturally responsive educational system within the Northwest indigenous context.
- 3. Develop a five-year strategic plan for the Northwest Unified Schools within the context of the Chuuk State Reform Plan (CERP) to be implemented in their respective school communities.
- 4. Engage the participants in the ethics of education using the Xavier High School educational system as a model to be replicated in the Northwest Unified Schools.

NEST Objectives

At the conclusion of the NEST, the participants will have accomplished the following objectives.

The principals will...

- 1. Acquire technical skills in school administration and management
- 2. Produce an actual school-based budget and strategies to manage the budget
- 3. Learn ways to plan and implement a teacher training program on classroom management, lesson planning, and student evaluation
- 4. Formulate culturally-appropriate ways to evaluate teacher performance and effectiveness that match standard educational evaluation process
- 5. Develop with the community leadership a community-based school improvement plan that fits into the daily schedule and culture of each municipality
- 6. Learn proper use of data collection and data analysis to identify school effectiveness and weakness
- 7. Develop a common Academic Calendar for the 2013-2014 academic year for the Northwest Unified Schools
- 8. Learn the CSSS system of ordering, receiving, and managing school supplies
- 9. Understand DOE's new organizational structure and the communication protocol with the appropriate direct supervisors at the Department of Education

The teachers will...

- 1. Formulate their personal philosophy of education
- 2. Learn basic lesson planning strategies for teaching local concepts
- 3. Learn strategies for assessing student learning styles
- 4. Produce some lesson plan templates for their subjects
- 5. Take an actual standardized test (Xavier Entrance Test or COM Entrance Test), scored, and get an analysis of their strengths and weaknesses
- 6. Formulate a system of improving their skills in teaching the various subject matters

The community leaders will...

- 1. Develop a simple plan of engaging the entire island community leadership and people in key educational reform efforts for the Northwest region.
- 2. Develop key strategic plans for implementing the Fanapi Center programs and services.

Facilitators

Arthur Leger, S.J., Ph.D.

Fr. Arthur Leger is the Director of the East Asian Pastoral Institute at the Ateneo de Manila University in the Philippines. A citizen of Fiji, Fr. Leger joined the Jesuits in Micronesia in 1994. He has a long career as an educator, both before joining the Society and afterwards including as Director and Principal of Xavier High School in Micronesia. He has completed Master's degrees in Educational Administration, Christianity and Culture, and in Divinity. He received his Ph.D. in leadership development from Gonzaga University in Spokane, WA. Fr Leger is especially alert to educational reform issues having been the lead consultant on the review of the Chuuk Educational Reform Plan.

Margarita Cholymay, Ed.D

Dr. Cholymay recently completed her doctorate at University of Hawaii at Manoa in education. Her dissertation entitled, "Way finding: Envisioning a Culturally Responsive Educational System for Chuuk State, FSM – Drawing Upon the Knowledge and Wisdom of Chuukese Indigenous People" will fit perfectly into the goals and aspirations of the Northwest Unified Schools to develop an educational system befitting their traditional cultures. She will focus her workshop on helping the educators and community leaders in formulating culturally responsive approaches to school improvement.

Vidalino Raatior, M.A.

Vidalino Raatior is the Director of the Pacific Islander Student Center (PISC) at the University of Hawaii at Hilo and is the founder and program manager for Fanapi Foundation. Formerly, he served as Assistant Director of International Programs at Santa Clara University. He is the founder and Program Manager of the US-based nonprofit organization Fanapi Foundation (www.fanapi.org/foundation). Vid attended public schools in the Northwest region and Chuuk High School. He received his bachelor's degree in communication from the University of Guam and a master's degree in school administration from the University of San Francisco. Previously, Vid served as a classroom teacher and assistant director at Xavier High School.

BUDGET NARRATIVE

Introduction

The proposed NEST budget has been streamlined to minimize cost while maximizing program effectiveness. This narrative explains each component of the budget within the framework of the school-based budget for the current fiscal year 2013 as published by the CSSS.

Funding Source

Understanding the limited financial resources in the State of Chuuk and the strict financial responsibility guidelines with which Compact funding are expended, the NEST simply requests for the reprogramming of existing school-based budget for the Northwest schools in the FY 2013. In several key planning meetings² the principals from the Northwest Unified Schools unanimously agreed to requests the CSSS to simply reprogram the balance of their school-based budgets for training estimated at \$9,000 to be used for the NEST expenses. Additionally, Northwest High School (formerly Weipat High School), which has an unused budget of \$29,000 for "fencing" requested the reprogramming of that balance toward the NEST. Together, these existing line items for training and fencing totaling \$38,000, which are at risk of being unspent by the end of the FY 2013 should adequately fund the NEST.

Expenses

Facilities - \$9,500

NEST'S proposed location at Xavier High School is strategic and economical. As the premier college preparatory in the Pacific, Xavier High School has a great deal of history and successful strategies which can be replicated in the public school systems. Having all the participants to reside on campus will allow the use of facilities and maximizes interaction among the participants. For a reduced cost of \$30 per person per day, Xavier High School will provide room and board, use of all classrooms, the Student Center, chapel, library, student kitchen, backup generator, 24-hour campus security, computer lab, office space for facilitators, shower house, male and female restrooms, all sports facilities, and 24-hour support staff.

² The series of planning meetings with Mr. Vidalino Raatior were done through the use of live Skype conferencing patched through the 2-way radios at each of the Northwest schools. All Northwest school principals or their representatives participated except for two schools which have no working radios.

Transportation - \$25,000

Providing sea, air, and land transportation for both the participants and the lead facilitators is the largest expense for this project. But it is a necessary expense given the geographical locations of the Northwest islands. Three ships must be chartered to bring the participants to Weno from the three regions and return them to their schools at the conclusion of the NEST. While on Weno, buses are needed to transport them to the Xavier High School campus in the village of Sapuk. Roundtrip airfare tickets are also needed to bring traininers to Chuuk specifically the principal facilitators, Fr. Arthur Leger, SJ, Ph.D. from the Ateneo de Manila University in Manila, Philippines. Mr. Vidalino Raatior, MA from the University of Hawaii at Hilo, and Margaret Cholymay, Ed.D., from the University of Hawaii at Manoa.

Professional Fees - \$4,000

This fee will cover minimal stipends and per diem for the facilitators and a team of local trainers who will help lead the various workshops. The stipend amount will depend on individual fees and the local rates.

Training Materials & Shipping - \$3,000

The NEST will require the purchase of some basic training materials including workbooks, pens, notebooks, binders, and printing cost for handouts, testing sheets, handbooks, and similar needs. These will need to be purchased in Hawaii or Guam and shipped to Xavier High School for storage prior to the NEST.

Miscellaneous - \$1,000

Funds are needed for miscellaneous expenses that may arise prior or during the training. It will also cover the 8% administrative fee required by the United Charitable Programs.
